II. Standing Items

- a. Hazmat Incidents
 - Neal Turner (Montgomery County) provided an overview of Hazmat incidents on the I-81 corridor, including a 100+ gallon diesel fuel spill at mm 109 southbound rest area. Cedar Hill assisted in the clean-up of this incident. He also reported on a 150+ gallon diesel fuel spill at mm 126.5 northbound. VDOT assisted in cleanup during heavy rain and ice.
- b. Educational Needs and Offerings
 - NSPA continues to provide training opportunities including NSPA Boot Camp (ongoing), Civil Rest Preparedness at the February Coalition Meeting (February 22, 2018, 2-3:30 p.m.), ICS 400 on March 12-13 in Roanoke, and ICS 300 on April 18-20 in Salem.  - ii. Virginia Department of Health is hosting Emergency Preparedness Exercise Design Fundamentals for CMS Providers on May 23 in Roanoke. (See attached flyer for registration information.)
 - iii. Stop the Bleed training is rolling out across the New River Valley, supported by local EMS agencies and at Virginia Tech. Mike Garnett provided a brief overview for all participants before providing the training at the end of the meeting.
