

# FY 2024-25 County Budget and Tax Rate Approved



On April 22, the Board of Supervisors approved its FY 25 budget of \$254.6 million, effective July 1. The Board approved a real estate tax rate of 75 cents per \$100 assessed value and personal property taxes remain at \$2.55.

The FY25 budget includes funding for education, public safety, human services, libraries, parks and recreation. For the first time, funding for paid firefighters in Eastern Montgomery is included. In addition, \$5.9 million in new County funding (which will be adjusted if additional funding is provided by the state) was approved for MCPS, bringing the total approved County funding for the MCPS operating budget to \$64.3 million. Total funding for MCPS including all federal, state, and local sources currently account for approximately 68 percent of the County's budget.

## Capital Improvement Program Includes Magistrate, Park, Library

The County's Capital Improvement Program (CIP) is a five-year plan that prioritizes and provides a funding mechanism for large-scale capital infrastructure improvements in the county. These improvements include significant upgrades to existing infrastructure and facilities and/or the addition of new infrastructure and facilities. In order to qualify as a capital improvement, a project must have a useful life of five years or more and cost at least \$50,000. Currently, the county is working on several capital projects outlined in the CIP. One significant project is the new Magistrate and Court Services Facility with a sally port, which is under construction at the corner of South Franklin Street and First Street in Christiansburg. The total cost of the project is estimated at \$8 million. The new facility will be a single-story structure providing offices, customer service areas, and conference rooms designed to accommodate



growth and meet all ADA accessibility requirements. This project also increases the safety for officers transporting prisoners to

the jail, as well as the community by the addition of a functional, enclosed sally port. (*Continued on next page.*)

Receive Broadband Updates from Provider

Construction continues on a project to bring high-speed internet to rural areas in Montgomery County. Gigabeam Networks is partnering with Appalachian Power to install fiber cable on existing power lines. Connections in the Elliston and Shawsville areas are anticipated to begin by summer 2024.

Residents and businesses in the County can sign up for high-speed internet at *www.gigabeam.net*. By completing Gigabeam's online form, citizens will begin receiving email updates about the project. gardens. The Montgomery Regional Solid Waste Authority provides mulch to County residents. *Minimize Fertilizer Use* Use slightly composted leaves in landscaping. The towns of Blacksburg and Christiansburg provide these to residents.

*Mow Lawns Properly* Set mower blades 2-3 in. high. The longer grass will take in more sunlight, which leads to a thicker, healthier lawn with deeper roots that can better survive drought, disease and insect damage. *Scoop the poop!* Pet waste washes into the streets, into the storm drains and ditches and then directly into creeks. Bagging pet waste is one way to reduce bacteria levels in streams.

*Test Your Soil* This will identify needs and help avoid wasteful spending on unnecessary additives. Learn more at Virginia Tech's State Soil Testing Lab: *www.soiltest.vt.edu*.

In addition, work will continue on the Auburn Park along Route 8 in the Riner area. This park will feature baseball, softball, and multi-purpose fields with lighting; a restroom facility; playground; picnic shelter; and walking trails. The estimated cost to complete this project is \$13 million.

Also underway are outdoor improvements along Draper Road at the Blacksburg Library. This project includes enhanced outdoor area accessibility, as well as several new and improved features for storytime and other outdoor library programs. The allocated budget for this project is \$650,100.
