Comprehensive Plan Amendment Process & Policies:

- Applications for amendments to the Comprehensive Plan are accepted and processed twice per year and must be received by 5:00 p.m. on February 28 or August 31.
- The Comprehensive Plan review process may take up to six months.
- Parcels which are currently in the Agricultural and Forestal District program will not be considered until they have been removed from the program.
- Parcels may be amended only to the Comprehensive Plan district level of adjacent or abutting properties.

All Comprehensive Plan Amendment Applications MUST INCLUDE ALL of the following:

- □ Completed application form
- □ Letter of justification, including specific plan citations:
  - 1. What you are intending to do with your property.
  - 2. Why the proposed use is an appropriate use for the property.
  - 3. How the change in proposed use fits with the land use policies and the subject policies included in the Comprehensive Plan.
- ☐ Traffic Impact Study (perVDoT 527 Regulations, when applicable)
- □ Plat of property or properties
- □ Map showing property and surrounding parcels
- □ Preliminary concept planning illustrating owner's intention for the property
- $\Box$  Application Fee \$500 (+ \$20 / acre)
- □ 10 copies of all application materials
