2. SCOPE OF PROJECT:

The project generally consists of removal and replacement of (7) skylights at the Montgomery County Government Center.

3. SPECIAL SITE/PROJECT CONDITIONS:

There is wood blocking called for on the drawings, contractor to install and paint to match the surrounding steel.

Roof warranty to be maintained. See TREMCO representative information attached for certified installers. Contractor will be responsible for maintaining the existing warranty.

4. STAGING AREA:

<u>Utilities, Site Limitations, Access, Parking, Storage:</u> Receptacles at loading dock may be utilized, Alley at the loading dock may be used for staging

Restrooms inside of the Government Center will be made available to the successful bidder for use during construction.

Interior roof hatch may be utilized to access the roof.

5. PROTECTION OF ADJACENT AREAS AND FACILITIES:

Protect all roof top equipment and gutters.
Plywood should be used to protect the existing roof.

6. COORDINATION:

7. CONTRACT(S) DETAILS:

Submittals shall be submitted within 30 days of Notice To Proceed. After approved submittal, and order confirmation, Contractor shall install within 45 days of material delivery. Total time from Notice to Proceed to Substantial Completion shall not exceed 180 consecutive calendar days, unless a delay has been approved by the County. Final Completion shall be achieved within 30 consecutive calendar days after Substantial Completion.

Liquidated Damages: \$500.00/day 180 days after NTP
